"WHO WAS THE FIRST" continued by Art Dycke

In the earliest days of the Palm Coast Historical Society, Margaret Davie, Mary Ann Canfield, Claire Sheekey, Debby Geyer and I began a project called "Who Was the First". It was designed to find out the earliest facts about people and events relating to the earliest history of our community. We have presented many of the accumulated "firsts" in our newsletter over the last five years. We would now like to enlist our readers help in providing more information in an expanded search for early leaders and events in Palm Coast's developing neighborhoods and its' ethnic, religious, civic, business and social groups.

In the January 2006 issue of *The Palm Coast Historian*, I featured the Collier family in an article entitled "Who has Lived in Palm Coast the Longest". In this issue I present Cynthia and Peter Abbot as our earliest residents who are of Caribbean heritage.

Peter and Cynthia met and married in Jamaica and moved to New York where he was an electrician and she a bookkeeper. They were among many who responded to media ads urging them to attend a home town presentation about a new planned development called Palm Coast in Also like many others, they signed up for a Florida. package to fly to Florida, stay at the newly constructed Sheraton Palm Coast Inn by the ocean, be taken by boat to the Welcome Center with its 64 foot high observation tower and then to buy a platted lot on a road that did not exist at the time. Cynthia and Peter moved to 28 Fairview Lane in At that time ITT's Palm Coast consisted of the 1974. Welcome/Model Center, Palm Coast Golf Club, the original Palm Coast Yacht Club, the Sheraton-by-the-Ocean, a Handy Way Convenience Center/Post Office and approximately 150 other homes.



Peter noted that there was one stop light and one blinking light in all of Flagler County and none in Palm Coast. Yet, Cynthia said, "We had so much fun here and everything was free! (She was referring to the fact that ITT had weekly buffets and entertainment for prospective home buyers that were open to all in the existing community.) See Picture 1 – Peter and Cynthia dancing.

Cynthia and Peter became citizens of the U.S. in the 1976 bicentennial year. That same year Cynthia established her own dress shop. She is pictured in Picture 2, left center, with Ria Edelman and Dorothea Griffen on the right, at a fashion show and buffet at the Yacht Club. The Show featured dresses from Cynthia's shop.

Peter worked for ITT at the Palm Coast Utility Corporation and continued there until his retirement in 1998. Some of his fondest memories of those early days involve the fabulous fishing in the ICW and canals of Palm Coast. See Picture 3 is of the Abbot family fishing in the Main Cannel circ 1974. Peter described catching "bushelsful" of a wide variety of fish, including "croakeys" any time he set his mind to it. He claims that two huge fish kills took place some time in the late 70's early 80's as a result of prolonged freezes during two years that ended the really good fishing. He wonders if anyone else remembers the events and when they happened.

Peter briefly considered leaving Palm Coast after his retirement but Cynthia would not hear of it. She says, "Then and now I love the people here and I wouldn't leave for anything". Picture 4 was taken in front of their home and they are holding a picture of their marriage 50 years ago in 1956.


